New Data Protection Laws, May 2018 - Please Read

April 2018

As you may be aware, from May 2018 the UK is adopting new regulations about how organisations, including charities like Opera Rara, are able to request, store and use personal data.

In response to these changes in law, this is a great opportunity for us get in touch to adjust or confirm how, and what type of communications you want to receive from us.

We want to ensure that these new regulations don't interrupt information we would like to share with you about our 2018 productions, events, recordings and development opportunities. We therefore ask you to:

Complete the form overleaf and post it back to Opera Rara.

OR

Visit www.opera-rara.com/mailing and complete the online form.

The process is simple and should only take a few minutes to complete. Opera Rara will process your new data preferences within 21 days of receiving them. If you wish to change your preferences at any point in the future, you will find an unsubscribe link on all our emails to you, which can be activated at any point. Alternatively, you can write to us, or call us at any time.

If you are a current Opera Rara donor or customer, you will continue to receive relevant communications from us associated with your membership or purchase, irrespective of your new data preferences.

From 25th May 2018, Opera Rara will be unable to contact you about any other aspect of Opera Rara until you have updated your preferences.
